There will be two First Aid people on the track and two in the pits.

Starting gate, switchboard, red lights and telephone connection to the pits are in working order.

Details of the Riders Briefing, the Parade and the Prize Giving ceremony were confirmed.




The Environmental Report was given to Jury President. There were no problems or major issues identified during the event. Recommendation - washing area.


It had been approximately 3500 spectators. During this meeting had been present President of SMF Peter Smižik, and 4 national TVs and one from Poland.
