## **PARTICIPATION OF RIDERS AND ENTRY FEES**

The event will be held according to the 2015 National Sporting Code for Country Cross and these Supplementary Regulations. The Slovak riders can participate with a valid SMF licence. Foreign riders can participate with a valid licence of their FMN together with a starting permission and appropriate insurance cover.

The entry fee will be payable at the administrative verification – **40 € for both days.**

## **TRACK**

The track is approximately 12 km and leads through field and forest lanes. Riding direction is the same on both days.

## **TIMEKEEPING**

Every rider will get a transponder, which he must put on his motorcycle according to the instruction of the timekeeper. The deposit for the transponder is 5€, which will be refunded after the race when the transponder is returned.

## **INSURANCE**

Each rider has to have an insurance cover for the case of permanent disability and foreign riders also for medical treatment and transfer to a hospital.

## **ENVIRONMENTAL REGULATIONS**

- Washing of the motorcycle is permitted only in the designed area – without any chemical substances
- Pouring or throwing away used oil or any other petrol waste outside the marked boxes is forbidden.
- The rider and his team are obliged to use the environmental mat (2 x1 m) while parking, repair works, refuelling and under the waste boxes. The environmental mat must be made of an absorbent part (upper part) and an impermeable part (bottom part).
- Canisters with oil and petrol and their throats have to be set out of the sunlight on the environmental mat
- Rider and his team have to respect the night-time curfew in the time interval set by the organizer and secure their motorcycles and other belongings against theft and damage.
- In the whole event area it is forbidden to damage flora and fauna.

These directions are mandatory and are in conformity with the NR SR law nu. 543/2002 ZZ. Any infractions of these rules may be penalised by 40 €.

## **FUEL**

The fuel will not be available at the paddock.

## **PROTESTS AND APPEALS**

Protests against a competing rider or motorcycle must be submitted to the Clerk of the Course within 30 minutes of the announcement of the results. All protests must be submitted according to the SMF Disciplinary Code and an advance payment of 40 € must be paid, which will be refunded if the protest is justified.
