



# Supplementary regulations

of the International Trial Championship of Slovak Republic and MACEC CUP,  
SMF CUP in the category of student, free and a mini trial free race

1. The competition is organised according to the National Motorsport regulations of the SMF for Trial, valid for 2014 and this Supplementary Regulations. The race can attend holders of FIM and FIME licence, holders of SMF-licence type A or B for trial, holders of licence for another disciplines within SMF, or one-event licence (valid only for certain race) for competitors without licences mentioned above. Foreign riders can participate with valid licence of their National federation. The event is announced for groups A, B, C – International Slovak Championship and for classes student and free – SMF Cup.  
Valid for race included into MACEC Cup: Competitors united in National Federations of BMX, SMF, FMU and PZM and starting in groups A or B, will be ranked in the MACEC CUP. Mini trial free race is for children up to 14 years of age with 80cc capacity motorcycles (two stroke motorcycles).
2. **Color coded categories:**  
A:-yellow color, B - green, C: - red, Free: - white, Student: - blue color,
3. **Place of the event:** Lazy pod Makytou (Directions to the paddock will be marked)
4. **Date of the event:** 03 - 04 May 2014
5. The track leads outside of the civil traffic. The length of one lap is 15 km, where each lap has 10 sections, and 3 rounds for categories A, B, C, Free. Riding time is 300 minutes. Track category for students is 0.5 km / lap, one lap has 5 sections and 3 rounds together. Mini trial free race will have a separate marked track.
6. The event has mass SMF insurance but each rider will confirm by signature on the Technical card, that he is insured according to the National regulations of SMF. The organiser doesn't undertake responsibility for any possible damage and losses occurring in relation to competitors and their equipment as well as directly or indirectly to third-parties and their property.
7. According to the valid general rules of SMF, riders without driving license are not allowed to ride bikes outside the race course.
8. Administrative and technical control will be done according to the regulation NO52,1 of the National regulations of SMF.

**12. Environment:** Washing up motorbikes is forbidden, except appointed place, where it is not allowed to use any chemicals for cleaning. It is allowed to put used oil and another waste only into appointed containers. For every service working with the motorbike it is necessary to use the pad made from absorbing material with dimension 2x1 m. All participants have to respect night-still during the period of time decided by the organiser. All participants have to take care about the plants and fauna in competition place. After breaking any environmental rules mentioned above, the organiser has the right to penalise the violator by 33,-€ penalty.
