1. OPENING HOURS OF THE ISDE SECRETARIAT

The application period opens on January 1 and runs until February 15, 2015. The National federations should fill in the attached form, indicating the amount of riders they intend to register for each category. Kindly send the complete form to us at: <u>info@fim-isde2015.com</u> and wait for a confirmation via email. A payment of 25% (EUR 162,50 men resp. EUR 120,- women) of the entry fee has to be made. The organizer will announce the number of teams accepted by country until February 28, 2013. Once this preliminary entry has been accepted, we will send each Federation a user and password to fill in the final online application of each rider.

The entry fee per rider is EUR 650,- (men), EUR 480,- (women) and the remaining balance has to be paid 12 weeks prior to the first day of the ISDE (no later than Jun 15, 2015). In order for your application to be accepted the final entry forms including team, name, class, motorcycle, frame number and registration number plate must be provided (with the same informatic procedure) until the closing date of July 27, 2015. The maximum number of entries is 480. In order for the official application form to be valid, it must be sent to the organizer including the confirmation of the payment of the entry fee for the rider (full name). Entries that do not include the payment confirmation will not be accepted.

3. STANDS FOR HOLDERS OF FIM LICENCES FOR MANUFACTURERS

The holders of FIM licenses for manufacturers and accessories who are interested in stands in the paddock area must submit an application in accordance with FIM rules stating the dimensions of the required area. These applications must be submitted to the ISDE Secretariat by June 28, 2015. From this date onwards the organizer can manage this area and may lease it to other interested parties.

4. PRESS CENTER

The press center is situated in the permanent media centre at the Hotel Kosice. The press center will open on September 3, 2015. 6. PADDOCK (ISDE CENTER)

The paddock of the 90th ISDE will be located at the area of the OPTIMA shopping mall and the Cassosport sport centre in the south part of the town Košice . The paddock area will open on August 31, 2015, from 12.00 noon. The number of cars allowed to enter the paddock will be limited. The paddock will be closed for vehicles from September 7 - 12, 2015 from 8.00 am up to the arrival time of the last pilot.

It is forbidden to reside in the paddock during the night from 9:00pm to 6:00 am.

7. PARC FERME







The parc ferme (closed parking) of the 90th ISDE will be situated in front of the OPTIMA shopping mall parking area.

8. ADMINISTRATIVE INSPECTION

The administrative inspection will take place in the paddock in the entry of the Cassosport sporting hall. All delegates and team managers are required to undergo the accreditation process at the ISDE Secretariat prior to the administrative inspection. Accreditation ends on September 4, 2015 at 6.00 pm.

The timetables of the administrative and technical inspection for each country will be posted at the ISDE Secretariat on the official website of the event unless on September 2, 2015 at 12.00 noon.

- Green card or similar certificate of international motor vehicle liability insurance valid in Slovakia. If you do not have a valid insurance certificate, the

organizer requires the bike to be registered with a Slovak insurance company (at the expense of the riders)

9. TECHNICAL INSPECTION

The technical inspection takes place near the parc ferme in front of the Optima shopping mall

- Motorcycles according to Article 061.41, 061.42, 061.43 and 061.44
- Original registration certificate of the bike (with framenumber) and the vehicle registration plate.

10. CLASSES

- Enduro 1: from 100cc to 125cc 2-stroke and from 175cc to 250cc 4-stroke
- Enduro 2: from 175cc to 250cc 2-stroke and from 290cc to 450cc 4-stroke



11. PRACTICE AREA

The practice area of the 90th ISDE will be situated near to the paddock. The direction will be signed by arrows. It will be open from September 2 - 5, 2015, from 9.00 am to 12.00 noon and from 2.00 pm to 6.00 pm.

12. ACCESS TO WORKING AREA

According to Article 061.54.5, the following persons will have access to the working area:

- 2 persons for each Trophy team
- 1 person for each Junior Trophy team and Club team
- The Clerk of the Course will take decisions in other exceptional cases.
- Accredited TV crews and photojournalists (passes will be available at the press centre)
- International Jury and FMN Delegates

13. ADVERTISING

It is strictly forbidden to place any banners, balloons, boards, flags etc. at the ISDE Secretariat, the paddock area, the parking lots, the special test tracks, the official route and any other places related to the event without the organizer's written permission.

15. NUMBER PLATES AND STARTING ORDER

Number plates and starting order comply with the FIM regulations. Advertising on the number background is reserved for the organizer. Riders have to declare that they have been informed of this obligation and that they agree to use the signage provided by the organizer during the competition. On the number background the starting number and the logos of the partners of the ISDE 2015 will be shown.

16. OPENING OF THE ISDE

The opening ceremony of the 90th ISDE will take place in the center of the city Kosice on Saturday. September 5, 2015 at 5.00 pm. The organizer will give precise instructions for the nations' parade and activities during the ceremony.

17. STARTS

The start commence will be in front of the OPTIMA shopping mall area each day at 8.00 am.

The start will take place in accordance with the Article 061.57 of the FIM ISDE Regulations.

18. COURSE

The total length of the course, including the special tests, is approximately 1225 km.

Day 3: Length of total course: approximately 260 km, each day with 2 laps. 4 time checks with service (including paddock) 6 special tests per day

Day 4/5: Length of total course: approximately 220 km, each day with 2 laps. 4 time checks with service (including paddock) 6 special tests per day

Day 6: Length of course: approximately 25 km, 1 time check and the final test on the Motocross Track in Kechnec in the south from Kosice.

19.SPECIAL TESTS

The venues and tracks of the special tests will be posted on the official board at the Secretariat of the contest on September 1, 2015.

20. UNAUTHORIZED FOREST ENTRY

Riding in the forest prior to the event is strictly forbidden unless supervised by the organizer's pre-riding team and the FIM course inspector. During the event is prohibited circulation on roads not open to traffic for not participating in the ISDE.

21. PENALTIES

The penalties for riders will be determined in accordance with Article 061.88 of the FIM ISDE Regulations.

22. HIGHWAY CODE FOR OPERATION ON PRIVATE HIGHWAYS AND PUBLIC ROADS

All riders and participants in the contest must respect the national traffic code for operation on all public and private roads and road crossings. They must conform to all instructions that are given by police, by the traffic marshals and







management. Please note that it is mandatory in Slovakia to keep headlights on all the time, even during daylight.

Riders failing to observe this instruction may be disqualified from the contest or face other penalties of the sporting code.

23. ORGANIZATION AND SAFEGUARDING OF THE MOVEMENT OF MOTOR VEHICLES

The entire area the Optima shopping mall, Hotel Košice and Cassosport sport center where the organization center of the ISDE 2015 is located (secretariat, paddock, parc ferme, start and finish) is restricted to public access. Closed separate parking areas are reserved for jury, press representatives, VIPs, officials, participants and teams. Parking badges and instructions will be assigned during accreditation.

24. FUEL AND TIRES

Any fuel used must be in conformity with the wording of Article 01.63 of the FIM Technical Regulations for Enduro. All tires used on the competition motorcycles must comply the wording of Article 01.51 of the FIM Technical Regulations for Enduro.
